Official Sweepstakes Rules ("Official Sweepstakes Rules")

BY ENTERING THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL SWEEPSTAKES RULES. AFFIDAVIT OF ELIGIBILITY / RELEASE OF LIABILITY AGREEMENT MAY BE REQUIRED. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited or restricted by law.

Employees of, members of the immediate family (spouse, domestic partner, in-laws, parents, grandparents, siblings, children, and grandchildren) of, or those domiciled with an employee (whether related or not) of Sponsor (as defined in [Section 10](#)), or its parent, affiliates, or subsidiaries, and Planet Smoothie® licensees, franchisees, and their employees are ineligible to participate or win.

Instagram is not a participant or sponsor, nor does it endorse, administer, or promote this Sweepstakes. You are providing your information to Sponsor and not to Instagram. 2. How to Enter the Sweepstakes. You must like, follow, and comment to receive an Entry. You may comment more than one time; however, doing so will not increase your odds of winning. You may also enter as described in the Alternative Means of Entry section below.

Entries that are incomplete, defamatory, disparaging, hateful, offensive, illegible, false, deceptive, garbled, or portraying or advocating alcohol, illegal drugs, tobacco, firearms or weapons, or Entries that include any activities that may appear unsafe or dangerous, or that advocate any political agenda are not eligible, with such eligibility to be determined by Sponsor in its sole discretion.

Limit: One (1) Entry per Entrant throughout the Sweepstakes Period. Entrants may only receive one (1) Entry into the Sweepstakes, regardless of whether they enter through Instagram or by email, or both. Entrants are not permitted to use another person's identity. Any Entrant, who uses multiple names or otherwise attempts to enter multiple times in violation of these Official Sweepstakes Rules, shall be disqualified from the Sweepstakes. 3. Sweepstakes Period. The Sweepstakes begins on August 4, 2025 at 9:00 AM Scottsdale, Arizona time and ends August 31, 2025 at 11:59 PM Scottsdale, Arizona time ("Sweepstakes Period"). Sponsor's computer is the official timekeeper for the Sweepstakes Period. Any attempted entries outside of the Sweepstakes Period will not be accepted.

4. Prize, Approximate Retail Value ("ARV") and Odds. All details and other restrictions of the prizes not set forth in these Official Sweepstakes Rules will be determined by Sponsor in its sole discretion.

Prize. Eight (8) Entrants (each a "Prize Winner" and collectively, "Prize Winners") chosen at random, will each be awarded one (1) gift card for Planet Smoothie valued at Twenty and 00/100 USD (\$20.00) ("Prize").

Total ARV: The total ARV of one Prize is Twenty and 00/100 USD (\$20.00). The total ARV of all Prizes is One Hundred Sixty and 00/100 USD (\$160.00). Any difference between the approximate retail value and the actual retail value will not be awarded or refunded.

Odds: The odds of winning a Prize will vary depending on the number of valid, correct Entries received during the Sweepstakes Period.

No substitution, assignment, exchange of cash, currency, credit, or transfer of the Prize by a Prize Winner is allowed. Sponsor reserves the right to substitute a Prize for one of equal or greater value. Prize Winners may be required to execute the Sponsor's affidavit of eligibility/release of liability/prize acceptance and any other documentation reasonably requested by Sponsor.

Sponsor reserves the right, in its sole discretion, to disqualify an Entrant if Sponsor: (a) learns or suspects that Entrant has misappropriated another's identity or infringed upon the rights of any person or entity; (b) finds that Entrant has tampered, is tampering or plans to tamper with the entry process or the operation of the Sweepstakes; or (c) believes that Entrant has violated these Official Sweepstakes Rules.
